**Determination of Non- Significance:** The City of Port Townsend, as SEPA lead agency for this project, has determined that the proposal will not have a probable significant adverse impact on the environment and issued a Determination of Non- Significance under the State Environmental Policy Act Rules (WAC 197-11-340). No probable significant adverse impact on the environment has been identified from adoption of the proposed amendments to the Shoreline Master Program therefor a Determination of Non-significance is warranted.

This comment period will be the only time to comment on the environmental impacts of the proposed project.
